**The Gregory and Dolores Farrell Scholarships** were first offered in 2004. They are supported by the family of the late Gregory and Dolores Farrell. Gregory Patrick Farrell OAM was a founding Director of the Foundation. The scholarships are available to students who use a wheelchair for mobility, who are undertaking an undergraduate or higher degree and for those who will be pursuing post-graduate study overseas.

The aim of the scholarship is to support integration into tertiary education. It is acknowledged that the student with a disability may have additional obstacles to overcome in accessing a tertiary education. One of these obstacles can be the additional costs involved to enable participation in tertiary education. The costs involved can be considerable and variable according to the degree of disability.

In 2012, four scholarships of up to \$5,000 each will be offered to students in New South Wales who use a wheelchair for mobility and are attending university.

**THE GREGORY AND DOLORES FARRELL SCHOLARSHIPS  
TO ASSIST STUDENTS WHO USE A WHEELCHAIR  
FOR MOBILITY TO MEET THE EXTRA FINANCIAL  
COSTS INCURRED WHILST UNDERTAKING TERTIARY STUDY**

**INFORMATION FOR APPLICANTS**

Travelling to and from university can be a major difficulty. Taxis can be one of the means of transport. The government meets taxi fares by providing those with a disability entitlement to a half fare taxi subsidy scheme, e.g. for a taxi fare \$60 the user pays \$30, the government pays \$30, and any amount over the \$60 is also paid by the user. However, it is still costly for those living some distance from the university campus. Government funding for disabled students wishing to pursue tertiary education is limited. Consequently, financial expenses remain a major burden.

It can be difficult for students with disabilities to access library and other university resources. It may be necessary to purchase more textbooks to enable the student to study at home in comfort and at ease. Many thick and tightly bound texts require the use of both hands to keep them open whilst reading. A page-turning device and/or photocopying these texts enables some students to read more comfortably and efficiently. Students with verbal communication difficulties may also require the assistance of communication software.

Other expenses may be the acquisition of computer modifications, e.g. turbo-ball, or other pointing devices and the upgrade of one's wheelchair. Further, in many cases, students require an electric wheelchair to cover large campus grounds.

Four scholarships are offered for tertiary students in NSW in 2012. Students must be Australian citizens, must use a wheelchair for mobility and have been accepted into a university course. Year 12 students (2011) may apply, if applications have been lodged for entrance to a University in 2012. Students who are proceeding to a higher degree are also eligible, as are students who have been accepted for post-graduate study in Australia or overseas.

Scholarship funds cannot be used to pay HECS.

Students who plan to undertake a TAFE course are not eligible.

Application forms are available on request by phone, mail or e-mail. Applications must be lodged by the close of business on Friday 10 February 2012.

A Selection Committee will choose successful applicants. If placed on a shortlist, it may be necessary for those applicants to attend an interview in Sydney. Successful applicants will be advised in the first week of March 2012.

As a condition of the scholarship, it will be necessary for successful students to submit mid-year and end of year results, as well as a report on how the funds have been spent. Funding has been made available for one year only, but successful applicants may apply for future years.

Students who are proceeding to a higher degree are also eligible, as are students who have been accepted for post-graduate study in Australia and overseas.
2. Applications must be lodged by the close of business on **Friday 10 February 2012** to the address below. Applications may be posted, faxed or e-mailed.
3. The successful applicants will be chosen by a Selection Committee. If placed on a short list, it may be necessary for applicants to attend an interview in Sydney in the first week of March 2012.
4. Successful applicants will be advised in the first week of March 2012.
5. As a condition of the scholarship, it will be necessary for the successful students to submit midyear and end of year results, as well as a report on how the scholarship funds have been spent.
6. Funding has been made available for one year only, subject to review for further assistance, but successful applicants may reapply for future years.
